## Subscription Terms and Conditions

### AT THE START OF YOUR SUBSCRIPTION

Print subscriptions start with the next available issue which may take up to 6 weeks to arrive.

### SUBSCRIPTION GIFTS

If the subscription that you purchased includes a gift, please allow up to 28 days for delivery. Gifts are sent out separately to your subscription copy of the magazine.

If you bought a gift subscription, any free gifts will be delivered to the purchaser unless you have specified otherwise. We reserve the right to substitute either the whole or certain elements of the gift advertised for one of equal or greater value. If circumstances require this we will notify you beforehand. In some cases, if a subscription offer includes a gift with a limited number available, no further gifts will be offered to those subscriptions received after the limit has been exceeded. Please check the terms and conditions of the specific offer at the time of ordering. However all other discounts on the subscription price remain applicable.

### DELIVERY OF YOUR MAGAZINE

Your magazine will usually be delivered 2-5 working days before the on sale date and no later than the on sale date each month. We accept no responsibility for late delivery that is outside our control, i.e third party distributors. If you do not receive your magazine by the on sale date please call customer services who can advise of any known delay or arrange a replacement copy if necessary.

### DIRECT DEBIT TRIAL OFFERS

Direct Debit offers are often preceded by with a short term trial period e.g. 3 issues for £1. We reserve the right to limit the number of trial subscriptions taken up consecutively if subscriptions are cancelled during the trial.

### THE DIRECT DEBIT GUARANTEE

This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.

If there are any changes to the amount, date or frequency of your Direct Debit, David Hall Publishing will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request David Hall Publishing to collect a payment, confirmation of the amount and date will be given to you at the time of the request.

If an error is made in the payment of your Direct Debit, by David Hall Publishing Ltd or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.

If you receive a refund you are not entitled to, you must pay it back when David Hall Publishing Ltd asks you to.

You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

### RENEWALS

If you pay for a subscription by direct debit there is no need to renew your subscription as it will continue until you cancel your direct debit and we will take payment every quarter/six months/year according to the subscription package you choose. You will continue to receive your magazine each month until you cancel your direct debit. If we change the subscription price we will inform you of this so that you can choose whether or not to cancel your direct debit.

If you have paid by credit or debit card or cheque, we will remind you that your subscription is due to expire before it does. If we have changed the subscription price since your last payment we will inform you of this in the renewal reminder notice so that you can choose whether or not to proceed with the renewal.

### REFUNDS AND CANCELLATION

Once we have accepted your subscription and payment, we regret that we cannot refund payment unless:

- (i) we are unable to fulfil your subscription. If this is the case and you have already received magazines for the period during which we are unable to fulfil your subscription, we will issue a proportionate refund;
- (ii) there are exceptional circumstances, which we will assess on a case by case basis. If decide that exceptional circumstances apply we may, at our reasonable discretion, give you a proportionate refund.

We may cancel your subscription immediately at our reasonable discretion or if you breach any of your obligations under these terms and conditions, including if we do not receive a payment when due from you.

If you pay for your subscription by direct debit you can cancel the direct debit at any time after your initial payment has been made by writing to your bank or building society. Please notify us of the cancellation at the same time. Your subscription will then end and we will advise of last issue to be received (if any). If you have a query about obtaining a refund, please contact our customer services team (see details in below).

### OUR RESPONSIBILITY TO YOU

We shall not be responsible for any failure by us to perform our obligations to you in relation to your subscription where this failure is caused by circumstances beyond our control. Our liability to you in connection with your subscription will not exceed the total subscription fees charged for your current subscription.
